### Payment Schedule:

Payment due at time of booking \$200

Cancellation Policy: The following penalties apply (notice of cancellation must be in writing)

Cancellations prior to July 1, 2008 - \$75 administrative fee applies.

Cancellations made between July 1 - September 4, 2008 - \$200 fee

Final payment is due September 4, 2008 - at which time all monies are non-refundable

**Insurance is not included and is highly suggested**

### Not included:

Insurance; airfare; extras ordered on table d'hote dinners; hotel incidentals (laundry, room service, phone usage, etc.); airport transfers; additional taxes/fees mandated nationally; anything not specifically indicated in itinerary.

Cost of \$1595 per person (double occupancy) land tour is based upon a minimum of 24 travelers.
